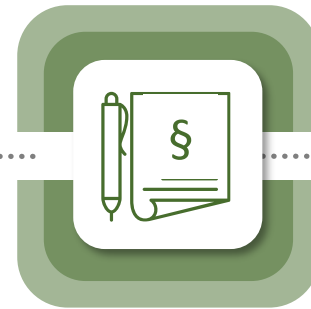

- The development of DCM is based on a stepwise approach to development and implementation, which is already reflected in basic versions of the systems

Where we are today: Process and IT

- TTR-Rollout so far:
 - Capacity Strategies (2025: 12 documents; 2026: 15 documents)
 - Capacity Models (2025)
- TCR Tool operative
 - Functionalities subject to continuous improvement
- ECMT operative
 - Capable of executing Cap Models and CNAs
- PCS Capacity Broker
 - Development expected to be launched November 2023



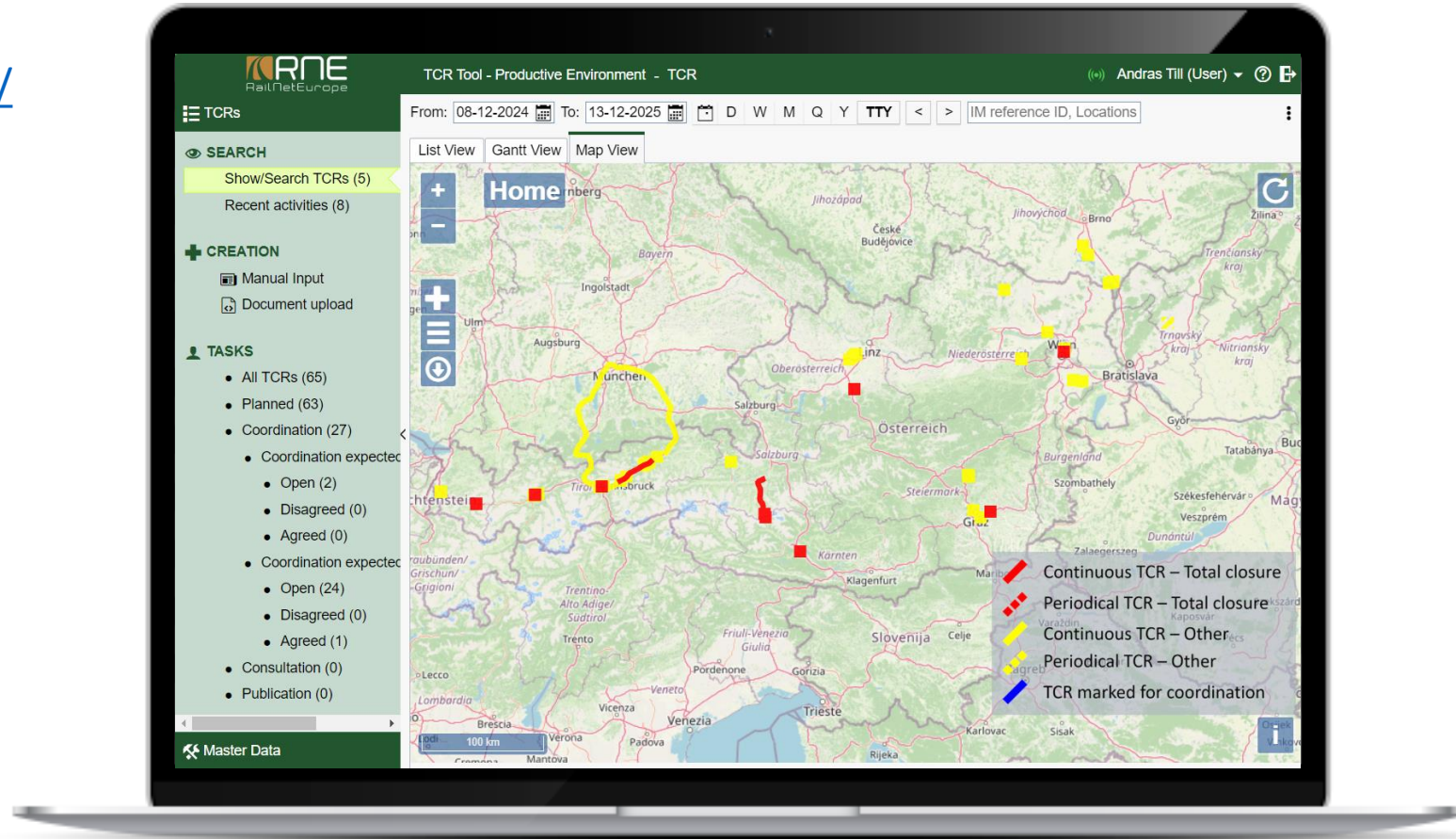

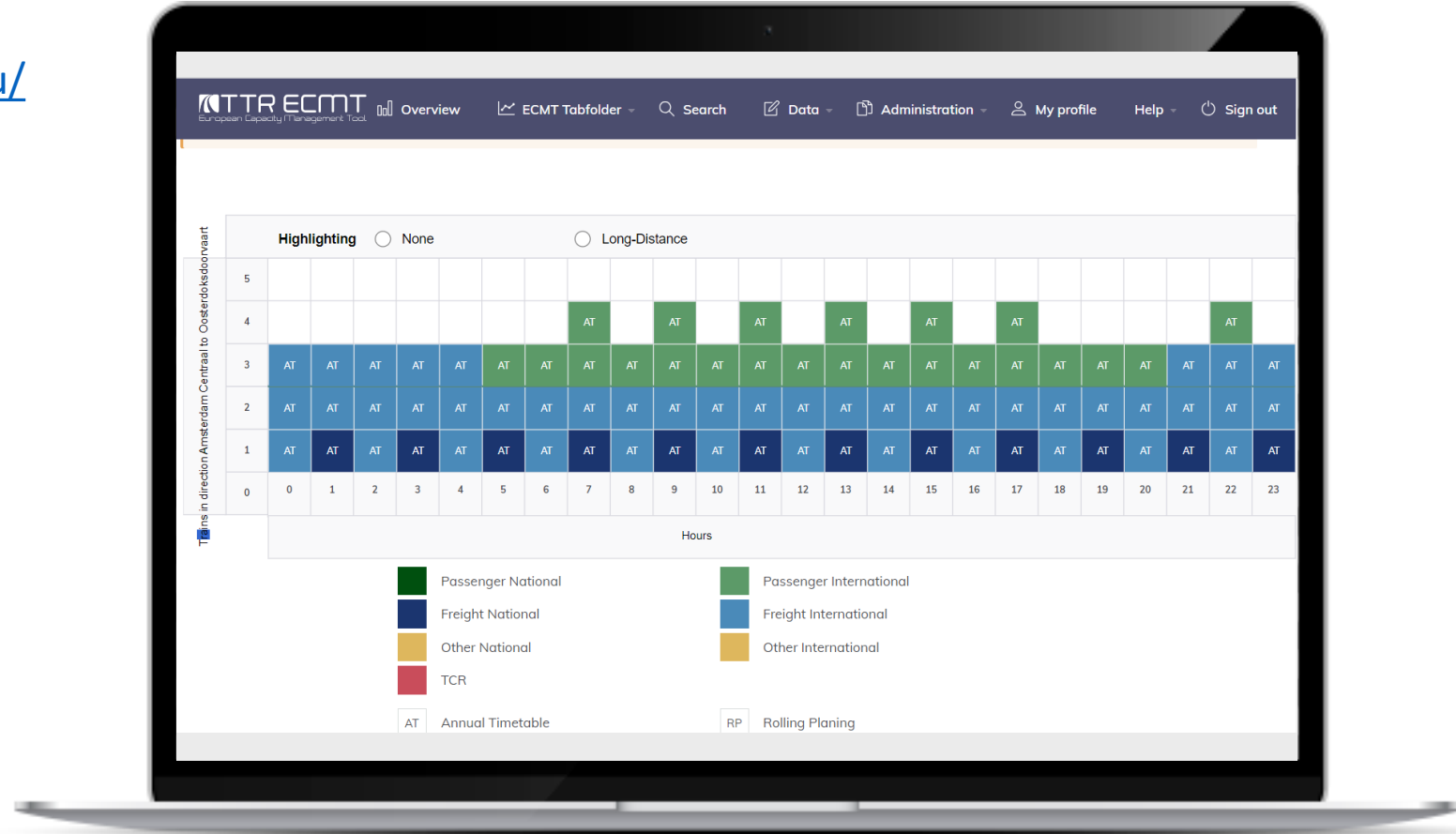

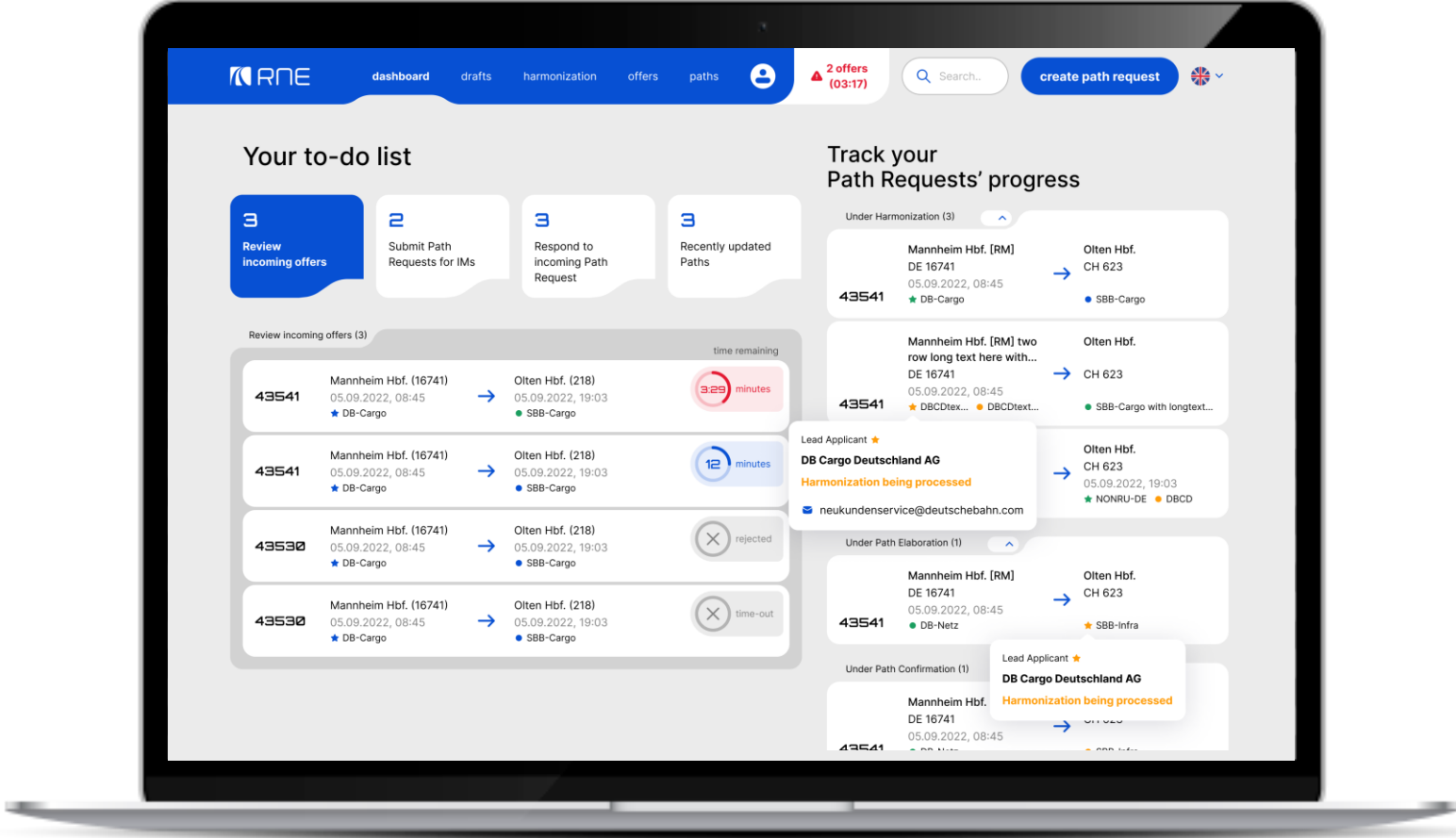
